DIAMONDHEAD WATER AND SEWER DISTRICT REGULAR BOARD MEETING MINUTES December 15, 2022 – 4:00pm (CST)

Diamondhead City Hall - Council Chambers, 5000 Diamondhead Circle, Diamondhead, MS

1. PRESENT BOARD MEMBERS: Chairman Bryon Griffith, Vice-Chairman Ben Taylor, Treasurer Louis Ertel, Commissioner Mark Beisecker (by phone), and Commissioner Arlen Griffey.

ABSENT: None.

The presence of a quorum was noted, and the meeting was called to order at 4:05pm. The public was duly notified in compliance with the District's open meeting policy.

2. Approve Agenda.

Motion by Commissioner Ertel, second by Commissioner Griffey to approve the agenda. Motion carried unanimously.

3. Public Comments.

- 4. Minutes.
 - 4.1. <u>Motion by Commissioner Griffey, second by Commissioner Ertel to approve the minutes for the Regular Board Meeting held on November 17, 2022. Motion carried unanimously.</u>

- 5. General Manager's Report.
 - 5.1. Update of Recent Events & Projects.
 - **5.1.A.** CB&I is scheduled to complete the erection for the Elevated Water Tank Project the week of December 19, 2022. The tank painting crew is scheduled to begin mobilizing on January 3, 2023. Painting is expected to take approximately 10 weeks to complete.
 - **5.1.B.** The Contractor for the Water System Improvement Phase II Project is scheduled to begin boring water service lines on Bayou Drive the week of December 19, 2022.
 - **5.1.C.** A Water Tower #1 Exterior Painting II Project meeting between the District, Digital Engineering and Tank Pro was held to punch-list the project on December 13, 2022. Tank Pro will be providing a schedule and plan of action to correct several pending items.
 - **5.1.D.** The Water System Improvement Phase III Project is approximately 40% complete. The remaining 6" and 8" diameter pipelines are scheduled to be installed the week of December 19, 2022. Approximately 100% of the 6" line is directional drill on the side streets of Hilo Way, Alawai Avenue, and Lanai Place. On December 14, 2022, the drilling crew impacted the existing 3" water main within the cul-de-sac of Hilo Place which caused a temporary shutdown for repairs. Water service was restored by early afternoon and a temporary boil water precaution

was issued to those residents. A second contractor crew nicked the existing 8" water main on Diamondhead Drive East near Hanalei Circle, which caused a temporary shutdown for three residents. Repairs were completed and water was restored that afternoon and a temporary boil water precaution was issued to those residents. District management and staff responded to both scenes within minutes and supervised all repairs. The Precautionary Boil Notices are expected to be lifted by December 16, 2022. A project meeting is scheduled December 16, 2022.

- **5.1.E.** CCTV of the lateral service lines and manhole lining is complete for the Sewer Improvements Basin 13, 16, & 17 Project. The contractor is working to complete the replacement section at Hanalei Circle and will be replacing the force main concurrently with gravity sewer all the way to the Diamondhead Drive East intersection. The contractor is working to complete the bypass at Lift Station #17 to finish the force main connections. Sewer main lining is expected to begin in mid-January with lateral lining to follow.
- **5.1.F.** After review of the abandonment of easement request for the property located on Akikai Drive, Phase 1, Unit 2, Block 10, between Lots 11 & 12, it was determined that this easement is of no use to the District at this time or in the future; therefore, approval of Abandonment of Easement is recommended.
- **5.1.G.** The District has performed 4 water service line repairs, 7 after hours leak investigations, 2 water main repairs, 2 sewer service backups, 2 sewer service line repairs, 2 sewer after hour calls, and installed 3 new residential water/sewer connections since the last meeting.
- **5.1.H.** The temporary emergency pipe support and culvert installed by the District at the Kolo Court drainage ditch are holding steady and the culvert is working. The temporary measures are an attempt to prevent further sewer main damage from an eroding ditch bank collapse. There has been no response from the City since the drawings were sent from Pickering Engineering on August 4, 2022.
- **5.1.I.** A meeting was held on November 17, 2022 between the District, Pickering Engineering, contractors, and the City Manager to discuss water and sewer infrastructure impacts and planning of water main interruption for relocation of pipeline on Makiki Drive.
- **5.1.J.** The District, in addition to the above projects, are managing District infrastructure for: (1) Conexon for Coast Connect Fiber in Fairway Villas and Glen Eagle, (2) AT&T fiber installations in Glen Eagle and Golf Club Drive, (3) Sparklight fiber installation, and (4) C-Spire on the MDOT Roundabouts Projects.
- 6. Construction / Engineering Projects.
