CONNECTION AND DEPOSIT FEE INFORMATION

HOMES, CONDOMINIMUMS, & APARTMENTS

This is a summary of information contained in the Water and Sewer Use Ordinances and the Water and Sewer Rate Ordinances currently in effect. It is intended to be a guide for the builder and new homeowner. The legal requirements are contained in the respective ordinances, and this information sheet shall in no way be construed as the legal information.

New Construction: Before a water and sewer connection permit can be issued, the owner of the property shall pay to the District the current connection fee for a 3/4" meter, as summarized below: (Plus tax on water connection for construction & business accounts)

3/4" WATER CONNECTION = \$1,078.00

3/4" SEWER CONNECTION = \$500.00

All new construction fees are defined in the DWSD Rate & Fee Schedule.

Deposit: Before the water and sewer connection permit can be issued, the owner of the property shall pay to the district a deposit and connect fee paid in two checks, for installation and use of the systems. (Plus tax on water connect & disconnect fees for construction & business accounts)
