# CONNECTION AND DEPOSIT FEE INFORMATION HOMES, CONDOMINIMUMS, & APARTMENTS

This is a summary of information contained in the Water and Sewer Use Ordinances and the Water and Sewer Rate Ordinances currently in effect. It is intended to be a guide for the builder and new homeowner. The legal requirements are contained in the respective ordinances, and this information sheet shall in no way be construed as the legal information.

**New Construction**: Before a water and sewer connection permit can be issued, the owner of the property shall pay to the District the current connection fee for a 3/4" meter, as summarized below: (Plus tax on water connection for construction & business accounts)

3/4" WATER CONNECTION = \$1,078.00

3/4" SEWER CONNECTION = \$500.00

#### All new construction fees are defined in the DWSD Rate & Fee Schedule.

**Deposit**: Before the water and sewer connection permit can be issued, the owner of the property shall pay to the district a deposit and connect fee paid in two checks, for installation and use of the systems. (Plus tax on water connect & disconnect fees for construction & business accounts)
